U.S. DOL Revises NEP for Silica Exposure.

This information is being provided to us by Region 2 Compliance Assistance Specialist James Giarraputo from the OSHA Regional Office. OSHA has established a revised National Emphasis Program (NEP) to identify and reduce or eliminate worker exposures to respirable crystalline silica, or RCS, in general industry and maritime (29 CFR § 1910.1053) and one for construction (29 CFR § 1926.1153). These industries are expected to have the highest numbers of workers exposed to silica. These standards became effective in June 2016. Compliance dates were September 23, 2017 for construction, and general industry and maritime compliance date was June 23, 2018.

Understanding Culture as Social Interaction:

Why blame and mistrust topple H & S programs

HSE executives and professionals worldwide believe that the most critical aspect of a strong safety culture is a workforce where employees speak up to stop unsafe actions and report incidents (DuPont 2012 global HSE survey). This presentation will examine this belief and provide the knowledge, tools and skills necessary to surface information needed to prevent accidents.

Have you ever wondered why workers didn't speak up or failed to communicate in critical operations? Historically, many accidents have been attributed to communication failure or the reluctance to challenge hierarchy. Such universal 'human causes' then become accepted as the truth often leading to enormous spending on training, retraining and a range of corporate initiatives aimed at addressing behavioural issues.

Presenter Rosa Antonia Carrillo's 2020 book, <u>The Relationship Factor in Safety</u> <u>Leadership</u>, has been suggested as mandatory reading for all who work with safety culture. She will focus on the role of relationships in safety performance and will present the latest developments in understanding culture as social interaction. Your ability to build relationships is at the core of your success as a safety professional and leader.

Nippin Anand will examine these issues more closely by looking at a real-life case study of one of the most high-profile accidents in the maritime history – the capsizing of the passenger ship Costa Concordia. We (video) interviewed the captain and analysed extensive data (from this and many accidents) to understand the underlying factors that impede communication and erode trust between team members. The insights we have gained from this accident are not limited to any specific company, ship type, maritime industry or the transport sector as a whole. These are common problems mirrored across industries where professionals work together to perform critical operations. Join us for a truly interactive experience if you are curious to learn and advance your knowledge in human factors and safety management.
